- If an error is made in the payment of your Direct Debit by The Seafarers' Charity or your Bank/Building Society, you are entitled to a full and immediate refund of the amount paid from your Bank/Building Society. If you receive a refund you are not entitled to, you must pay it back when The Seafarers' Charity asks you to.
- You can cancel a Direct Debit at any time by simply contacting your Bank/Building Society. Written confirmation may be required. Please also notify The Seafarers' Charity.
